Chapter Directors Board Minutes, October 23, 2018

The quarterly Board Meeting was held on Tuesday, October 23, 2018 at the Spring Creek Barbeque Restaurant, 571 Round Grove Rd., Lewisville, TX. Present at the meeting were President Wayne Smith, Treasurer Jim King, VP Trips and Events Skip Waters, Secretary Jerry Nunn, and member Bob Kennedy. VPs Jon Shea and Valli Hoski did not participate.

President Wayne Smith called the meeting to order about 7:50 PM. Wayne had called the meeting to coordinate the transition to a new Treasurer, since the current Treasurer Jim King will be stepping down in at the end of the year.

Jim also handled the extra duties of Membership Chair. It was decided that beginning in 2019 that the Membership and Treasurer duties be split. Bob Kennedy has agreed to assume the Treasurer position, and Secretary Jerry Nunn has agreed to take over the membership.

To facilitate the transition, a detailed description of the Treasurer and Membership activities and tools was written. This document available upon request to the President.

The remainder of the meeting covered details of the transition to the new Treasurer and Membership Chair. Here is a summary of the main points of the discussion:

- Jim King uses the software package QuickBooks to manage the Chapter's finances and membership. The software
 features many more functionalities than the Chapter requires, and its cost is too expensive to justify its purchase by the
 Chapter. Jim has converted the membership/dues list to Excel format, and emailed copies to Bob Kennedy and Jerry
 Nunn, who will use Excel and Word or some free or low cost substitute to manage membership and finances.
- Regarding membership, the National Chapter sends out membership notifications. The local Chapter needs to send out notices for 2019 Chapter North Texas dues soon. The Excel spreadsheet has email addresses to facilitate this requirement.
- The Chapter has a mailbox, but does not receive a lot of mail. Skip Waters checks the mail about every 2 weeks, and will continue to do so. He will open the mail, and if a check or invoice is received, take a photo and send them to Bob Kennedy. Skip and Bob are authorized to deposit a check.
- The Chapter has a PayPal account for its financial obligations, which can be handled from a smart phone. Bob will need to secure appropriate authorization s to manage the payments.
- Bob Kennedy needs to be a signee on the Chapter's bank account at Bank of Texas. Jon Shea is the point of contact on this issue. A letter with President Wayne Smith's signature may be required.
- As a non-profit organization, the Chapter pays no income taxes. However, the Chapter submits a short form to the IRS each year. Jon Shea does this task.
- The Chapter has an online store, which can be used to purchase books, pay dues, and add events to the events calendar. Kim Hinton (webmaster) is the point of contact about the online store.
- The Chapter still occasionally sells a "Southern Pacific" book. On October 1, the Chapter pays the royalties (10% of book sales) to the author, for the first six months of sales. On April 1, the Chapter pays the royalties for the remainder of the year. The Chapter will continue to pay royalties until all books are sold.

The next Chapter meeting will take place at Sokol Hall on November 13 at 6 PM. The December meeting is the annual Christmas dinner, scheduled December 4 at the Babe's Chicken Dinner House in Frisco, TX.

- Copies of minutes from the recent chapter Board Meeting were distributed.
- Jeff Phelps was selected as Nominations Chair for the upcoming chapter elections in January.
- The annual chapter Christmas party will be held again at Babe's Chicken in Frisco on our regular meeting night. We will do a gift exchange again at the party and ask all attendees to bring a wrapped gift.
- The chapter agreed to purchase two tables at the upcoming Dallas Area Train Show in Plano. We again will pass out membership information at the show as well as sell donated items for our heritage grant program.
- Jon Shea passed around a recent copy of The Katy Flyer with a significant amount of the issue covering the historical Sherman Subdivision with photos and articles. It also included an article about the historical Katy Depot in Smithville, TX.
- Also, copies of The Newsletter of the Red River Valley Railroad Historical Society, Inc. November 2018 were passed out
 to members which discussed a very special opportunity to learn about O Winston Link's photography from a family
 member.

After the business meeting, we proceeded with the auction and raised \$81.00.


